



**Rectoral Decree:** *Call for admission to the PhD Programmes, XXXVI cycle, academic year 2020/2021*

## THE RECTOR

In accordance with the legislations and regulations, both internal and external to the University of Foggia

## DECREES

### Article 1 Places available

It is hereby established, for the academic year 2020/2021, the 36<sup>th</sup> PhD cycle of Doctoral Research Programmes at the University of Foggia.

Notice is hereby given of the selection procedure, based on qualifications and interviews, for admission to the following Ph.D Programmes:

**ECONOMY, CULTURE, ENVIRONMENT. ECONOMIC AND HUMANISTIC SCIENCES FOR THE VALORISATION OF TERRITORIES (Appendix A);**

**MANAGEMENT OF INNOVATION IN THE AGRICULTURAL AND FOOD SYSTEM OF THE MEDITERRANEAN REGION (Appendix B);**

**TRANSLATIONAL MEDICINE AND MANAGEMENT OF HEALTH SYSTEMS (Appendix C);**

**NEUROSCIENCE AND EDUCATION (Appendix D);**

**LEGAL SCIENCES (Appendix E).**

The appendices shall constitute an integral part of this announcement and shall specify, for each PhD course, its places available, characteristics of these courses, the type of qualifications required for application onto the course and any additional requirements and procedures for admission.

### Article 2 Entrance requirements

The Ph.D. programmes are open to all applicants, regardless of nationality, who at the application deadline are in possession of the academic qualification as indicated in the respective appendices (A-E) or an equivalent academic qualification from a foreign university.

Moreover, candidates may apply for the post as long as they are in possession of the admission requirements by 31 October 2020. They will be admitted 'with reserve' and the selected candidates must prove that they are indeed in possession of the admission requirements no later than 5 days after getting the relevant entry degree, otherwise they will be excluded. A self-declaration on the obtained degree can be produced.

The University administration may, at any time, exclude applicants because of the lack of the above-mentioned requirements.

Candidates with a qualification obtained at any foreign University must hold a II Level academic qualification (according to the Bologna process) or Master Degree level, which gives access to PhD course in the country of origin and is issued by an officially recognized academic institution:



- Candidates already in possession of a certificate of equivalence of their qualification, issued by an Italian university must attach to their application a self-certification (clearly indicating the provision numbers)

- The suitability of a foreign qualification without a certificate of equivalence will be assessed by the Selection Committee in compliance with Italian regulations and that of the country where the qualification was issued and international treaties or agreements on the recognition of qualifications for the continuation of studies. In particular, for the purpose of such recognition, candidates must attach to the on-line application any documentation deemed useful to aid the assessment.

The online compilation of the application involves the implicit request to ascertain the suitability of the qualification obtained abroad.

Foreign applicants must attach to their online application:

- A copy of the degree, duly translated into English, French, Spanish or German, and, if available, "A declaration of value";
- A copy of the residence permit, if non-EU citizens, as the admission test might require an interview in person.

Candidates holding the qualification obtained at any foreign University, if winners of the selection, must provide the title held and the certificate of the title with exams and grades translated and legalized by the Italian diplomatic or consular representatives of the country where it was issued. The declaration of value must certify that the title held is valid in the country of attainment for enrollment onto the PhD Program.

### Article 3 Application procedure

The application for admission to the abovementioned PhD Programs must be submitted only through an electronic procedure, within the peremptory deadline of **15/09/2020 h 12.00 AM (Italy time)** through the Esse3 portal of the University of Foggia accessible at the following address <https://unifg.esse3.cineca.it/Home.do>

It is the candidates' responsibility to verify the correct completion of their online application procedure; therefore, complaints will not be accepted for possible malfunctions of the IT system. Candidates are invited to complete their application well before the deadline.

Access to the online procedure is subject to registration with the ESSE3 system, according to the following procedures:

- candidates already registered at the University of Foggia must select the LOGIN menu item and access the Reserved Area using their login details. Candidates are invited to update the data already present in the registry, in particular the e-mail address to which all communications relating to the PhD program application will be sent, by selecting the item HOME;
- candidates not registered at the University of Foggia must select the REGISTRATION menu item and enter the required personal data; they can then, by selecting the LOGIN proceed in entering the login details received from the system, to access their private area and fill in the online application.

In case you forget your password, from the menu item you can select "Password Recovery" on the aforementioned page.

Once registered, candidates must click on link SEGRETERIA, which can be found in the menu on the left, then, from the same menu, the following links TEST DI AMMISSIONE – ISCRIZIONI CONCORSO, and then the PhD program for which you would like to enroll on.

Candidates must also:



- indicate the language (Italian or English) in which they intend to take the tests, specifying any aids if required (for candidates with disabilities), enter their qualifications and follow the instructions provided by the system;

- attach, by uploading, the following documents, under penalty of exclusion from selection:

- 1) A photocopy of a valid identification document;
- 2) A curriculum vitae et studiorum (obligatorily signed at the bottom of the page and containing the following words: "I declare that what is written in this curriculum corresponds to truth in accordance with the Decree by the President of Italian Republic no. 445/2000);
- 3) A list of the enclosed qualifications and publications;
- 4) Pdfs of the publications;
- 5) A "research project" proposed on issues related to the Doctorate (kindly specify the project title and, where provided, the selected *curriculum*);
- 6) Any letters of reference, written by highly qualified subjects;
- 7) A declaration on the absence of situations impeding participation of the PhD course in the case of a positive outcome;
- 8) Candidates registered as RESERVE, self-certification of exams taken for the attainment of the Master's Degree / specialization and related study plan;
- 9) For foreign applicants, who request an online interview, a declaration of availability to carry out the interview on the day and time indicated by the selection committee.

Qualifications and documents must be attached in electronic PDF format not exceeding 5 MB each. Each attached file must be named according to the type (eg "CV", "Recognition document", "Research project" etc ...).

The qualifications, the CV, the research project and any letters of reference may also be written in English.

Please take note that any only online registration without the requested or unsubscribed attachments will not be taken into consideration.

**The candidate must complete the registration by making the payment of the admission fee of € 52.00 on the PagoPA circuit, no later than 15/09/2020 (this sum is in no case refundable), accessing the personal page - Secretariat section → Payments.**

Candidates who wish to apply for more than one of the PhD programs must register on the portal for each research program, attaching the required documentation and making payment for each program. Failure to pay the admission fee will result in exclusion from the selection procedure. **Candidates who have obtained their qualification abroad are exempted from paying the admission fee.**

In the online application, candidates with disabilities (according to the Law of February 5, 1992, No. 104, supplemented by the law January 28, 1999 No. 17) or with Specific Disorders of Learning - DSA (under the law October 8, 2010 No. 170) must also produce an explicit request for help and / or additional time for conducting the exam.



The prescribed requirements must be available by the deadline of the call, with the exception of the degree, which, for those who will apply with reserve, can be made available by October 31, 2020, as indicated in this article.

The University Administration assumes no responsibility in the case of lost communications due to incorrect contact information provided by the candidate, failure, or late communication of the change of contact information or any postal or telegraph errors, not attributable to Administration itself.

#### **Article 4 Nomination of the adjudication commission**

In accordance with art. 14 of the University Regulations concerning research doctorates, the adjudicating commissions for the admission tests to the doctoral schools are appointed by the Rector, on the proposal of the Doctoral School Board.

#### **Article 5 Admission tests**

Candidates will be selected based on the assessment of the following:

- **Qualifications** (publications, CV, research project – to be drawn up by the candidates themselves – and any letters of reference);
- **Interview** (on the research themes related to the Doctorate, discussion of the proposed "Research Project", English Language knowledge); at the request of the individual candidates, the interview can be held in English.

Before the evaluation of qualifications, the individual Commissions will establish the evaluation criteria of the qualifications.

The interviews will be held at the University of Foggia on dates which will be published on the University website ([www.unifg.it](http://www.unifg.it)) and on its electronic notice-board or listed in the Appendices of each PhD Course ( A- E ) at least 20 days beforehand. These publications are legally valid notifications.

Candidates residing abroad, on request, be interviewed online, via compatible platforms. In this case, they will have to fill in and attach the form provided, including their email address and Skype contact details. Furthermore, the candidate should declare that they agree to have the interview on a date and at a time stipulated by the panel, and that they are aware that, failing to be reached at the stipulated time, their application will no longer valid.

NB. Due to the current COVID-19 emergency situation, interviews could be provided remotely for all candidates. The applicant's email address will be then used to set up the relevant virtual rooms for connection.

Candidates will receive details and information near the day arranged for the interview, in any case at least 4 days before same interview. Notice will be given on the University Telematic Register, and published on the University website [www.unifg.it](http://www.unifg.it)

The University of Foggia will not take any responsibility for technical problems, which prevent the video-conference from being set up. In the case of the candidate not being available at the time of the call for the interview, the candidate will be declared absent.

#### **Article 6 Merit ranking**

The Commission shall give each candidate up to 60 points for qualifications and 60 points for the interview.

At the end of the examinations, the Commission will compile a list of merit based on the scores obtained.



Candidates are admitted to the Courses according to the ranking order up to the number of available places for each Course.

The scholarships reserved for students with a foreign degree will be awarded according to the ranking list for the candidates with a foreign degree eligible for admission. In the case of not assignment, the position with scholarship reserved for students with a foreign degree will be moved to the general ranking, increasing the number of scholarships available for the PhD program.

A separate list of merit may be provided in case of grants allocated by companies or third-party organizations for *ad hoc* research topics.

#### **Article 7 Admission to the programmes**

Candidates will be admitted to the Ph.D programmes according to their ranking in the classification, until the places available are filled. In the case of two or more candidates obtaining the same score, the grant will be assigned on the basis of the candidates' financial situation (as indicated by the ISEE certificate). In case of further parity, preference will be given to the youngest candidate (art. 2, comma 9, Law number 191, 16/06/1998).

The classification of the successful candidates will be published on the University website ([www.unifg.it](http://www.unifg.it)), on the university's electronic notice-board and also viewable on the Esse3 personal page.

#### **Article 8 Grants**

Grants are assigned on an annual basis and are renewed on condition that the Ph.D student has completed the activities on his/her programme for the previous year, as verified by methods decided upon by the panel of professors.

The awarding of the scholarship will be carried out by the Teaching Committee of each PhD program according to the outcome of the tests and / or of the research project entrusted to the PhD student for the research purposes of the funding bodies.

The annual gross amount of the grant, as defined in the Ministerial Decree n.40 of 25/01/2018, is €15,343.28 pre-tax with contributions to be paid by the student, and is subject to separate social security payments (INPS).

In the case of a study abroad period, the PhD student is entitled to an increase in the pro-rata scholarship equal to:

- 70 percent, for scholarships funded by the University of Foggia or other universities, research institutions or other institutions, which expressly provide for it in the relative agreement stipulated with the University of Foggia;
- 50 percent, for scholarships funded by universities, research institutions or other institutions according to the agreement with the University of Foggia, without any additional provision of 20%.

A zero-grant PhD student could enjoy of financial aids provided and allocated, for instance, within *ad hoc* mobility programmes.

Grants will only be assigned to students whose gross annual income does not exceed €12,000.00; this requisite is subject to an annual evaluation. If, between one academic year and the next, a student's financial situation changes and he/she is no longer eligible for a grant, he/she will not be required to pay back money already received. However, if the student's financial situation changes during the academic year and he/she is no longer eligible for a grant, then he/she will be required to pay back the instalments already received.

Grants for the Ph.D programme are not accumulable with any other type of grant except those awarded by national or foreign institutes for helping to finance research periods abroad. In the latter case, the student is not eligible for an increased scholarship for periods of training abroad.

Students, who have already been awarded a grant, even in part, for attending another Ph.D programme (either at the University of Foggia or at another university) cannot be awarded one of these grants.

The scholarships that are financed / co-financed by external public and / or private research companies /entities, will be provided to the grant recipient, subject to the actual income from the University of Foggia of the relative sums.

### Article 9 Registration

**Successful candidates will not receive any written communication.**

The aforementioned must proceed to the online registration on ESSE3 platform, with the same login details used during the application process, make the payments requested through Pago PA and complete and send the relevant PhD enrollment form to Servizio Alta Formazione, **under penalty of forfeiture, within the peremptory term that will be indicated at the time of the publication of the ranking list on the University Telematic Register.**

The modalities and terms of enrollment will be published on the official online register of the University of Foggia and on the university website, [www.unifg.it](http://www.unifg.it), in the section dedicated to Research Doctorates, no later than the date of publication of the general merit rankings.

### Article 10 Fees and contributions

Pursuant to the University Tax and Contribution Regulations, doctoral scholarship holders are required to pay annual fees and contributions.

The amount due is divided into four solutions:

- I installment: equal to € 300.00 (to be paid upon matriculation);
- The installment: equal to € 400.00 (to be paid by 31st January 2021);
- III installment: equal to € 400.00 (to be paid by April 30th 2021);
- IV installment: equal to € 400.00 (to be paid by 31st July 2021).

All PhD students are required to pay a stamp duty of € 16.00, and the Regional Tax, which is based on the family income (ISEE Form), the amount indicated in the following table:

Regional tax	ISEE
€120.00	up to € 23.000
€140.00	from € 23.001 to € 46.000
€160.00	€ 46.001 and above

It is specified that:



- PhD students who have obtained the qualification abroad are exempt from paying taxes and contributions. They will therefore pay stamp duty and the Regional tax;
- PhD students with a disability of not less than 66% are required to pay stamp duty of € 16.00.
- PhD students with disabilities between 45% and 65% are entitled to a reduction in the amount of taxes and contributions of 50% and are required to pay stamp duty and the Regional tax.

#### **Article 11 Academic training of doctoral students**

Admission to the Ph.D programmes entails an exclusive, full-time commitment, with the exception laid down in section 4 of articles 7 and 11 of the Ministerial Decree no.45/2013. The student is obliged to attend the course on the basis of the guidelines laid down by the Doctoral School Board.

A Ph.D student may be excluded by Rectoral provision motivated by the Doctoral School Board in the case of a negative evaluation of an activity he/she has carried out in one of the verification-tests stipulated in the organization of the course.

Students shall carry out educational and research activities, established by the PhD Faculty Committee (Professors), also at affiliated facilities.

Ph.D students with a grant must spend at least 90 days' study and training abroad (either consecutive or not), at a qualified research unit identified and agreed upon by a tutor, and authorized by the Doctoral School Board. Ph.D students without a grant are also advised to undertake a period of study abroad.

The maximum duration of study and training abroad during the PhD program should not exceed 18 months (with or without interruptions of the stay period abroad). PhD students with scholarships who cannot fulfill the obligation of 90 days of study and training abroad are required to apply for exemption to the PhD Committee of their Research Doctorate; the Academic Board may allow exoneration from the period abroad exclusively for the following reasons: serious and documented health problems; maternity; serious and documented family reasons, proved delays in issuing the residence permit on behalf of the relevant Authorities to the applying students.

PhD students with scholarship funded by another University affiliated with the University of Foggia or by Research Centres having an agreement with the University of Foggia, and PhD students, who do not possess a scholarship, whose research topic is relevant to *curricula* in agreement with another University are exempted from this obligation.

#### **Article 12 Final examination and conferment of title**

The title of research doctorate, abbreviated as "Dott.Ric." or "Ph.D.", is issued following a positive evaluation of the research thesis, which contributes to the furtherance of knowledge and methodologies in the given field. The thesis must be written in either English or Italian, or in another foreign language if so agreed by prior consent by the Doctoral School Board.

The thesis must be discussed within three months of the termination of the Ph.D course after admission to the final exam by 'evaluators'; discussion may be deferred by up to a maximum of 6 months if so requested by the 'evaluators' should they decide that significant additions or corrections to the thesis are necessary.

For the conditions and terms for presenting the thesis, Ph.D students should follow the guidelines laid down in the "Regolamento di Ateneo in materia di dottorati"

The title of Research Doctor is conferred by the Rector.

#### **Article 13 Publication of the doctoral thesis**

A copy of the doctoral thesis, as laid down by art. 33 of the University Regulation of Doctoral Research will be deposited by the competent University authorities in the ministerial database and sent to the central libraries of Rome and Florence

#### **Article 14 Processing of personal data**

Personal data will be processed in compliance with the principles set out by the EU Regulation no. 679/2016 regarding the protection of personal data. Attached to this call is the information on the processing of personal data. #### **Purposes of data processing**

The data will be processed in compliance with the principles established by the GDPR, within the institutional scope of the University of Foggia, for participation in the public selection for admission to the XXXVI PhD courses. Your data will also be processed in order to:

#### **Consequences of failure to disclose personal data and consent to the treatment of data**

### Data retention

### Data management

Your personal data may be made available to:

3. Subjects who process data in execution of specific legal obligations;
4. Judicial or administrative authorities, for the fulfilment of legal obligations;
5. Third parties, who process the data for institutional purposes;
6. Private companies, for recruitment purposes; in the event of profiling activities, it is their obligation to inform the interested parties in advance.

### Profiling and dissemination of data

Your personal data will be processed anonymously for the fulfilment of publication obligations imposed by law. Rights of the interested party. Among the rights recognized by the GDPR are those of:
